Therefore, by signing below, I knowingly assume the unavoidable risks inherent in all horse-related activities, whether known or unknown, including but not limited to bodily injury and physical harm to horse, rider and spectator, and agree to the following on behalf of myself and my spouse, if any:

- 1. I hereby release and discharge Georgetown Divide Equestrian Trails Foundation (GDETF), the GDETF board of directors, all GDETF officers, and individual club members and their agents, employees, or representatives (hereinafter collectively known as "releasees") from all actions, claims or demands i may now or hereafter have from injury, death or damage resulting from my participation in any horse-related activities sponsored by GDETF, at any location.
- 2. I also EXPRESSLY WAIVE any rights I may have under California Civil Code 1542, which states, "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor.
